LESSON # 10 – YOU SHALL NOT BEAR FALSE WITNESS

INTRODUCTION

Why do we have difficulty telling the truth? (i.e. "Does this dress make me look fat?")

OBSERVATION/INTERPRETATION

Note: "The last five of the Ten Commandments provide a wall of protection around those things we cherish the most. They are there to restrain evil conduct on the one hand and to provide peace of mind and comfort on the other." <u>The Ten Offenses</u> by Pat Robertson. The Ninth Commandment is repeated in Deuteronomy 5:20. "In Exodus the meaning is lying or untrue; in Deuteronomy the meaning is insincere, empty, frivolous. The meaning is not essentially different, but the Exodus version concerns the nature of evidence while Deuteronomy emphasizes the spirit in which it is given." <u>The Ten Commandments</u> by William Barclay.

Read Exodus 20:16

- 1. What does it mean to bear false witness? Ps 24:4; 12:2-4
- 2. What provision did God put in the law to help preclude this violation? (Duet 17:6 & 19:15) Note: Man works cleverly to get around this rule. Jezebel, King Ahab's wife, knew that she needed two witnesses to fulfill the law in 1 King 21:13. The Pharisees knew they needed two witnesses for Jesus to be put to death in Matthew 26:59-61. Both were false witnesses.
- 3. How might slander ("to speak critically of another person with the intent to hurt or defame") or gossip (rumor, the spreading of reports about others) relate to being a false witness?

Read Acts 5:1-11

- 4. How was Ananias guilty of bearing a false witness (lying)?
- 5. What did Sapphira do to perpetuate the lie?
- 6. What did Ananias and Sapphira have to gain by lying about the money?
- 7. What does God think about lying? Why was this such a serious violation? Lev 10:2; Gal 6:7 2 Sam 6:7
- 8. In what circumstances do we lie to God? To man?

APPLICATION

• How seriously should we take the concept of lying and bearing a false witness? What actions can you take to conform to God's standard?
